

A negotiator must ensure:

- Contracting party is correctly named
- Pl is not a party
- Sponsor indemnification/liability
- Publication rights
- IP ownership and protection
- Protocol, SOW, Budget align
- HIPAA, FERPA, or other privacy rights
- F&A/overhead
- Use of UVA's name
- Confidentiality

- Ownership of materials, equipment
- Disposition of data
- Use of data and results
- Flow down provisions
- Insurance requirements



What we can't agree to

- Statutory prohibitions (indemnification, binding arbitration)
- Waive requirements for legal/equitable actions
- Restrictive publication terms and delays
- Liability for employee conduct outside scope of employment
- Give up right to use study data and results
- GDPR, other foreign privacy laws
- Foreign governing law or venue
- Waiver of sovereign immunity
- Terms that are inconsistent with VFOIA

- IRB determination (human subjects)
- COI management plan
- CITI training/disclosures are current
- Export Control/Research Compliance
- IACUC approval (animal research)
- Policy waivers
 - i. risk assessment for foreign law
 - ii. publication restriction

 - iv. lack of indemnification or subject injury language
 - v. nonconforming safety notification




What takes extra time

- Internal approvals (IRB, data certification, IT/data security plan, LVG review)
- Seeking waivers, ancillary reviews in Huron, risk assessments
- Negotiating essential terms (IP ownership, data rights, liability, HIPAA, publication, governing law, etc.)
- Revisions to SOW, protocol, budget

What causes delays

- Volume per negotiator
- Compliance/approvals and documentation
- Huron submissions (missing or inaccurate information)
- Sponsor delay, non-responsiveness, inflexibility
- Urgent, deadline-driven, complicated contracts



What's needed every time

- An agreement request in Huron
- An adequate description of research
- Budget/proper F&A
- Contact information for the sponsor
- Appropriate supporting documentation
- Appropriate internal approvals



What you can do to help

- Huron and other training
- Preliminary discussions with the negotiator
- Provide required compliance and other documentation
- Assume every agreement needs to be negotiated
- Do not sign any agreements!

What we're doing to improve efficiency

- Reviewing the waiver process
- Streamlining our processes (individually and as a team)
- Reassigning/reallocating
 portfolios
- Collaborating with other units
- Outreach/training to research community
- Better communication and transparency



In 2024, the Contracts Team negotiated nearly 2,000 agreements

Approximately 140 agreements per negotiator
